## Political News

As of January 18, 2026, key bills to watch in the Florida Legislature include expanding **E-Verify mandates for employers (HB 197)**, allowing **wrongful death suits for fetal loss (HB 289)**, addressing **water quality and environmental issues (SB 1386, general environmental bills)**, tightening college admissions for non-citizens (SB 1052), and significant budget/policy discussions around **AI (Artificial Intelligence)**, rural health, and education. Many bills from the first week are moving to committees, with a focus on immigration, education, and health policy shaping the early session.

### Key Bills & Topics:

- **Immigration/Employment:**
  - **HB 197 (E-Verify Expansion):** Requires all employers to use E-Verify, a federal system for checking worker eligibility, passed the House and moves to the Senate.
  - **SB 1052:** Would restrict public colleges to admitting only U.S. citizens or legally present individuals, impacting adult education programs.
- **Health & Families:**
  - **HB 289 (Fetal Wrongful Death):** Allows parents to file wrongful death lawsuits for the loss of a fetus at any stage, passed the House.
  - **Rural Health Transformation Program:** A major \$209.9 million annual grant program (from the federal "Big Beautiful Bill") is being implemented.
- **Environment & Water:**
  - **SB 1386 (Septic Tanks/Water Quality):** Mandates septic tank inspection programs and better pollution monitoring.
  - General focus on water pollution, conservation lands, and protecting marine life.
- **Education:**
  - Bills on cursive instruction (HB 127) and teacher oaths (HB 147) are being considered.
  - Discussions continue on managing school voucher programs and enrollment drops.
- **Technology & Budget:**
  - **AI Regulation:** Governor DeSantis prioritizes an "AI Bill of Rights," with Senate proposals filed.
  - **Budget:** Negotiations are ongoing for the 2026-2027 fiscal year budget.
  - Governor Ron DeSantis has already asked for a special session following the regular session to work on special redistricting.
