The President’s Missive

“It is not possible to be in favor of justice for some people and not be in favor of justice for all people.”--*Martin Luther King Jr.*

As I sat at my computer tonight to write this missive, our precious democracy was threatened by the failure of congress to advance the Freedom to Vote Act and the John Lewis Voting Rights Advancement Act. This vote has “effectively ended hopes of implementing national standards around election procedures that could have blocked some of the most restrictive new GOP laws” in several presidential battleground states, including Florida, that have imposed restrictive new election laws in 2021.

As a Democratic Committeewoman in Melbourne Village, I spent many hours going door to door to educate our villagers about the voting changes for our last election. Governor DeSantis and his Republican majority in Tallahassee had made voting more complicated and less voter-friendly. Vote By Mail ballot applications now needed to include a driver’s license number or the last 4 numbers of the voter’s social security #. The application was now only good for 2 years rather than 4 years of receiving a VBM ballot. There were a limited number of drop boxes available, and the time frame for mailing the VBM ballot was shortened.

An effective means of assisting voters in African-American neighborhoods to vote was called “Souls to the Polls.” After Sunday church services, buses would be waiting to bring the worshipers to the polls, until the state eliminated early voting on Sundays. Limiting the number of polling locations in underserved communities created long lines and hours of waiting. People were thirsty and hungry, but it was now prohibited to pass out any water or food to anyone waiting in line to vote.

In a democracy, every citizen should have the right to vote, and everyone is treated equally and has equal rights. Nearly all recent polls show that Americans believe democracy is under threat. Here in Florida, Governor DeSantis wants you to believe the lie that there is widespread voter fraud in our state. His latest proposal is “the creation of something called the Office of Election Crime and Security.” He is asking GOP lawmakers to approve a \$6 million “special police force to oversee elections, a proposal that election experts say could lead to intimidation of voters and organizers.”

Martin Luther King Jr. once said, “The time is always right to do what is right.” What will you do to bring back justice to all the people? What will you do knowing that the United States Senate failed our democracy tonight?

Legislative Report

The Florida Legislature is now in session for 2022.

Governor Ron DeSantis, in his State of the State address, emphasized over and over that Florida was a free state and how much money he had available to distribute. He used the governor's platform to make a campaign speech against the Biden administration and spoke on ending critical race theory, which is not taught in our public schools.

He spoke on Liberal attempts to defund police, ending abortion with the Texas abortion law, expanding gun access and the creation of a new election integrity unit and advocated for freedom for anti-maskers and those holding anti-vaccine views, while pushing issues of allowing parents to have access to teacher lesson plans.

He made no mention of the large number of deaths due to covid, the affordable housing crisis, the need for health care, food shortages and help for the homeless.

Right after speeches by Governor DeSantis and the Legislative Leadership proclaiming the "freedom" of the Sunshine State, legislation in the Senate that would hide the selection process for college and university presidents, which was clearly against the sunshine laws, moved forward along with bills to preempt our local communities right to have home rule.

The cash surplus Governor DeSantis took credit for having is from the cash sent to Florida in stimulus funds by the Biden Administration.

There are specific Education bills to watch:

SB1048 High Stakes Testing, which does not end the problem, just changes the group from whom the tests are purchased and increases the frequency of testing

SB 506 Dealing with Vouchers

SB 758 Charter School Expansion, which takes supervision of charter schools from local school boards.

Plus there are bills other dealing with the election of members of local school boards.
