Legislative Report

The Florida legislature is at it again with several very bad bills.

I urge you to follow the actions of the legislature by going online and viewing the weekly review produced by the AFL-CIO.

House Bill 1 is a direct attack on workers' right to organize and designed to bust unions. It is one of the most outrageous attacks on the working people of the state in years. The bill would severely damage the right to organize for our firefighters, police officers, teachers and all state workers.

If passed, House Bill 1 would give employers the power to decide the authorization process for employees and force union members to rejoin their union every three years or upon the authorization of a new contract. This means the union would have to chase down re-authorization forms from members who have no intention of leaving the union.

After the employer receives a signed dues authorization, deductions would not start until the employer goes on to "confirm with the employee, electronically or by other means, that he or she authorized the deduction of dues and uniform assessments." This puts the employer in charge of the dues authorization process for the first time in history. Our public sector workers will have an indeterminate period of confusion and fear as they wait for the employer to verify their membership. There is no time frame or penalty for employers in the bill.

Public sector workers understand their Right to Work. This language is intended to tip the scales against membership.

On Feb. 13, House Bill 1 passed the State Affairs Committee 12-7.

Some other very bad legislation--**House Bill 7037 and Senate Bill 1794**--deals with the right of citizens to put an amendment on the ballot. Florida's Citizen Initiatives give the people of the Sunshine State a direct voice in our government, adding legislation to the constitution that our State Legislature either cannot or will not approve. Last week, many advocates for democracy, including the Florida AFL-CIO, spoke out against this attack on our democracy. Senate Bill 1794 passed the Senate Judiciary Committee 4-2 and will continue on to its final stop, the Senate Rules Committee before heading to the Senate floor.

Harry was a pioneer in the civil rights movement nationally and in Brevard County. Sonya will be speaking about the Moores, their place in history, and conditions in Brevard County for African Americans at that time.

On March 25th we'll be going to the Moore Park and Museum. Touring the Moore complex takes about 2 hours. Admission is free. We'll be having lunch at La Cita Country Club at 11:30, before going to the Moore complex. La Cita is at 777 Country Club Dr. in Titusville.
