Stetson, of Stetson hat fame, this estate was Florida's first luxury home. The home is recognized as one of USA Today's "10 Best Holiday Home Tours in the US" (It ranks #5 nationwide) and is Tripadvisor's #1 landmark attraction in Florida. Explore lavish interiors filled with original mosaic parquet flooring, thousands of antique glass panes, and an array of unique handcrafted details—plus the distinction of being Florida's first snowbird home, the first home with electricity, (Mr.Stetson was best friends with Thomas Edison) steam heat, indoor plumbing, and a call-bell system (like on Downton Abbey). Florida Following Texas in Redistricting


Florida is getting ready for a major redistricting process in 2025, driven by the political motivations of Donald Trump and demands from Ron Desantis.

Florida House Speaker Daniel Perez has announced the creation of a select committee to explore redistricting options. This committee aims to address potential changes to congressional maps ahead of the 2026 elections, with discussions expected to begin in the fall of 2025. While the legislature could wait until the regular session in January 2026, there is pressure to act sooner, possibly through a special session in mid-October 2025.

The redistricting process is contentious, with accusations from Democrats that the Republican-led efforts are aimed at consolidating power and diminishing Democratic representation. If the new maps are drawn favorably for Republicans, several Democratic incumbents could be at risk of losing their seats. The Republican-led panel could make Florida's Republican-favoring congressional map even more Republican. Florida's current congressional map favors Republicans. The state sends 20 GOP Representatives to Washington, D.C., and only eight Democrats. The Florida House has already created a committee to explore changing the map. House Speaker Daniel Perez has named its 11 members; eight are Republicans. Republican Rep. Mike Redondo of Miami will be its chairman. He's slated to become House speaker following the 2030 election.

There are also ongoing legal challenges related to previous redistricting efforts, with accusations of racial gerrymandering affecting several congressional and state legislative districts. These legal battles may influence the current redistricting discussions and outcomes.

DeSantis and Trump say they want a mid-decade Census count, but who will pay for it? Florida Taxpayers again?
